# What makes Day School different?

## We aim to develop the whole child.

Our program is aimed at developing the whole child: physically, spiritually, emotionally, socially, and academically. Children learn all the basic skills through active learning experiences designed to encourage them to explore the world in which they live-to discover, create, and communicate through developmentally appropriate activities. Our theme-based curriculum and whole language approach provide a meaningful and challenging environment.



## We accommodate varied learning styles.



We offer a variety of fun and stimulating activities, including learning centers and small groups. Music – song, dance and instruments – tied into the current theme, as is art, which emphasizes the creative process rather than the product. Play generated from creativity, energy and imagination encourages large motor skill development in either our fenced playground or (in inclement weather) our indoor playground.

## Our children attend chapel each week to learn the stories of Jesus.



We welcome families of all beliefs, yet we are unapologetically Christian. Each week children age toddler and older participate in a brief Chapel time consisting of a lesson, songs, and a prayer – all reminding them that God loves them always. We teach our children the stories of Jesus, so that his story may become their story.

## We offer learning enrichments.

We are excited to include enrichment opportunities for all ages. A music teacher provides weekly lessons, Spanish is taught in all age levels, and Pre-K classes spend time in our computer lab each week.



## Our student to teacher ratio is small.

Compliant with state regulations, each year our teachers receive 15 hours of training in early childhood education. In preparation for school-readiness, our Pre-K classes have an early childhood or education degreed teacher. We provide two qualified teachers for each class, and the maximum number of children per class is: Pre-K: 16; Three Year-Olds: 14; Two Year-Olds: 12; Toddlers: 10; and Nursery: 8.

## Ready for your child to join Day School?

### Enrollment and Registration

Registration for each school year begins in the Spring and continues while spaces are available. A waiting list is maintained throughout the school year. The Day School does not discriminate on the basis of race or religion.

To register, you must complete an enrollment card, and pay a non-refundable registration fee and a first semester supply fee, which is refundable before June 1. All fees and tuition costs are outlined on the insert in this brochure.

Upon enrollment you will receive a copy of the policy and procedures. You will also receive a health form to be completed and signed by a doctor. Around August 1 you will receive notification of your parent-teacher meeting date and confirmation of class in which your child is enrolled. Your signed health form is due by that meeting date.

### Class Schedule

All classes are 9 a.m.–2 p.m. and are based on the age of the child on or before September 1. Children bring their own lunches; daily snacks are provided. Holidays, in-service, and inclement weather days are observed with the Hurst-Eules-Bedford ISD calendar, with some exceptions.

\*Tuition may be paid in nine installments, due on the first day of each month, September through May. Monthly payments are calculated as an average of the annual tuition, not based on class days per month.

Registration for 2011–2012 begins Tuesday, March 1, and continues while spaces are available.

**Family Discount:** If two or more children in the same family are enrolled in Day School, the first child pays regular monthly tuition, and each additional child pays regular tuition less \$10.

### Registration Fee per Child:

\$100 (Non-Refundable)

\$90 for Early Registration (By April 15)

**Supply Fees** are payable at the time of registration and with January's tuition. These fees pay for reusable curriculum materials, expendable supplies and major equipment used by each child. Supply fees are non-refundable after June 1.

One day a week: \$40/semester

Two days a week: \$80/semester

Three days a week: \$120/semester
